-Communication to the public for CHARITABLE or EDUCATIONAL PURPOSE that do NOT fall under the exemption in Section 184.1(1)(i) of the Intellectual Property Code ("IP Code"), shall be subject to 25% of the applicable standard rate; Provided, that during the pandemic, and until further notice, the fee shall be waived;

-Communication to the public for RELIGIOUS PURPOSE (OTHER THAN FOR RELIGIOUS INSTITUTION), shall be subject to 25% of the applicable standard rate; Provided, that during the pandemic, and until further notice, the fee shall be waived;
